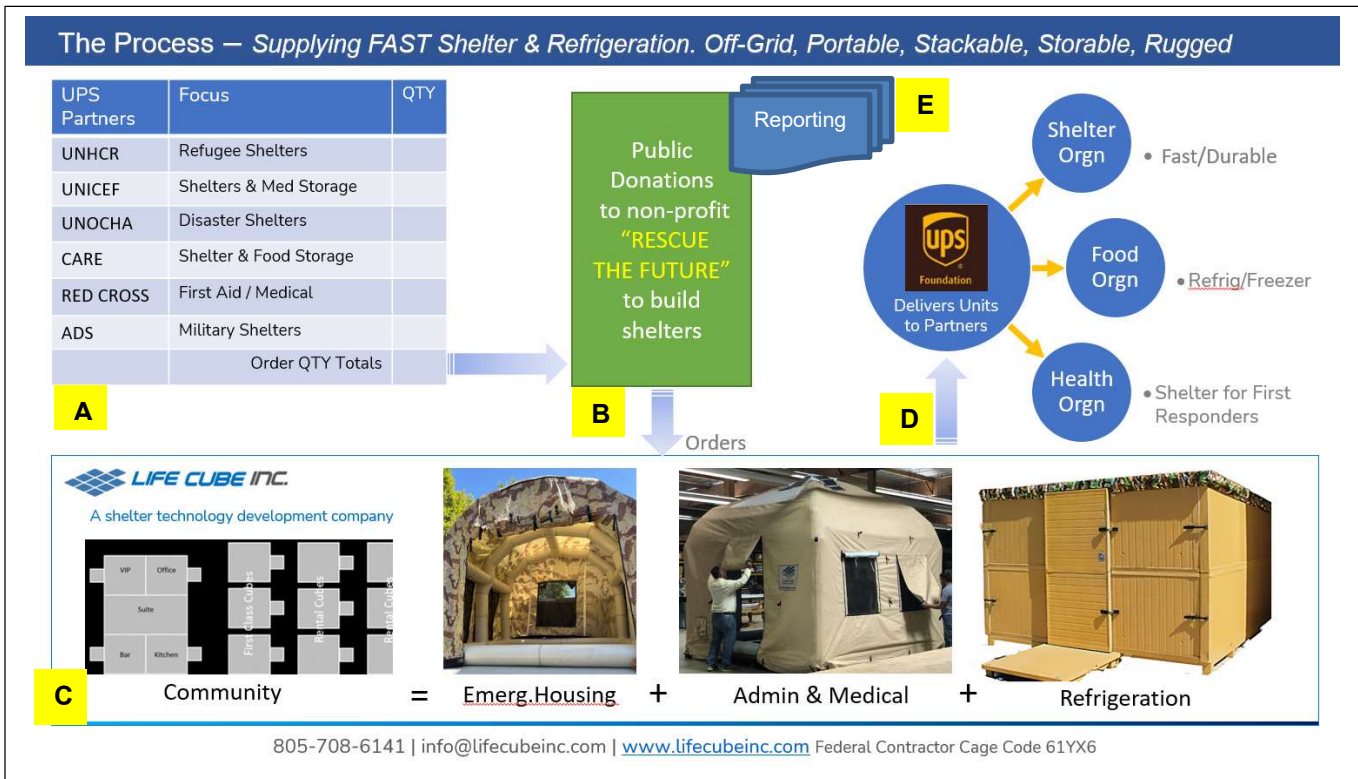

THE PROCESS

- A. Life Cube, Inc is helping several agencies quantify shelter and refrigeration requirements.
- B. “Rescue the Future” is an alliance between Life Cube Inc and charity organization Green2Gold, which facilitates the funding and ordering process of the shelters. As an internal, fundamental project/program, Green2Gold will be responsible for all fiduciary and legal issues for these programs.
- C. Various shelter and refrigeration models, produced by Life Cube Inc with their subcontractors, are configured for either community or individual sites.
- D. Product is delivered to aid organizations in the field. There may be grant opportunities for these organizations to receive free shipping, as depicted below with an example of the UPS Foundation.
- E. Quarterly reports will keep donors apprised of the project progress and impact.

1. What are the benefits of donating?
